Bidding will be conducted through national competitive procurement using Request for Bids (RFB) as specified in the World Bank's Procurement Regulations for IPF Borrowers dated July 2016 (Revised November 2017 & August 2018) ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations & Bidding Document.
4. Interested eligible Bidders may obtain further information from the Office of the Employer and inspect the Bidding Document during office hours [Monday to Friday] at the address given below.

Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on **July 13, 2023 at 1430 hours**.
8. The Bids must be accompanied by a Bid Security as mentioned above, for each contract package in the shape of unconditional Bank Guarantee or Call Deposit Receipt (CDR).

Attention is drawn to the Procurement Regulations for IPF Borrowers dated November 2020 requiring the Borrower to disclose information on the successful Bidder's beneficial ownership, as part of the Contract Award Notice, using the Beneficial Ownership Disclosure Form as included in the Bidding Document.
